1. INTERPRETATION AND DEFINITIONS

In this document, clause headings are for convenience only and shall not be used in its interpretation unless the context clearly indicates a contrary intention:

- 1.1 an expression which denotes
 - 1.1.1 any gender includes the other genders;
 - 1.1.2 a natural person includes a juristic person and *vice versa*;
 - 1.1.3 the singular includes the plural and *vice versa*.
- 1.2 The following expressions shall bear the meanings assigned to them below and cognate expressions bear corresponding meanings:
 - 1.2.1 "Information Officer" (IO) the designated Information Officer as described in the Manual
 - 1.2.2 **"Deputy Information Officer" (DIO)** the designated Deputy Information Officer as described in the Manual
 - 1.2.3 **"Manual"** this document together with all of its annexures, as amended from time to time, and published in terms of Section 51 of PAIA
 - 1.2.4 **"PAIA"** Promotion of Access to Information Act 2 of 2000, as amended from time to time including the regulations promulgated in terms of PAIA
 - 1.2.5 **"POPIA"** Protection of Personal Information Act 4 of 2013, as amended from time to time including the regulations promulgated in terms of POPIA.
 - 1.2.6 "Regulator" Information Regulator of South Africa as established in terms of section 39 of POPIA

2. PURPOSE OF THIS PAIA MANUAL

This PAIA Manual is published in terms of section 51 of PAIA which requires organizations to compile a manual as a guide to requestors of information.

This Manual is intended to serve as follows:

- 2.1 Indicate the types of records held by Apollo Tyres Africa (Pty) Ltd and the availability of such records from Apollo Tyres Africa (Pty) Ltd;
- 2.2 Provide the public with a sufficient understanding of how to make a request for access to a record of Apollo Tyres Africa (Pty) Ltd, by providing a description of the subjects on which Apollo Tyres Africa (Pty) Ltd holds records and the categories of records held on each subject;
- 2.3 Provide a description of the records of Apollo Tyres Africa (Pty) Ltd which are available in accordance with any other legislation;

- 2.4 Provide access to all relevant contact details of the Information Officer and Deputy Information Officer who will assist the public with the records they intend to access;
- 2.5 Provide a description of the guide on how to use PAIA, as updated by the Regulator and how to obtain access to it;
- 2.6 Inform the public as to the personal information Apollo Tyres Africa (Pty) Ltd processes, the purposes thereof, the categories of data subjects relating thereto, the recipients or categories of recipients to whom the personal information may be supplied, and whether or not Apollo Tyres Africa (Pty) Ltd plans to conduct transborder flows of personal information;
- 2.7 Describe on how Apollo Tyres Africa (Pty) Ltd has planned to transfer or process personal information outside the Republic of South Africa and the recipients or categories of recipients to whom the personal information may be supplied; and
- 2.8 Describe the appropriate security measures implemented by Apollo Tyres Africa (Pty) Ltd to ensure the confidentiality, integrity and availability of the personal information which is to be processed;

5 GUIDANCE ON HOW TO USE PAIA AND HOW TO OBTAIN ACCESS TO THE GUIDE

- 5.1 The Regulator has, in terms of section 10(1) of PAIA updated and made available the revised Guide on how to use PAIA ("**the Guide**"), in an easily comprehensible form and manner, as may be reasonably required by a person who wishes to exercise any right contemplated in PAIA and POPIA.
- 5.2 The Guide is available in each of the official languages and in braille.
- 5.3 The aforesaid Guide contains the description of:
 - 5.3.1 the objects of PAIA and POPIA;
 - 5.3.2 the postal and street address, phone and fax number and, if available, electronic mail address of:-
 - 5.3.2.1 the Information Officer of every public body; and
 - 5.3.2.2 every Deputy Information Officer of every public and private body designated in terms of section 17(1) of PAIA¹ and section 56 of POPIA²;
 - 5.3.3 the manner and form of a request for:-
 - 5.3.3.1 access to a record of a public body contemplated in section 113; and
 - 5.3.3.2 access to a record of a private body contemplated in section 50⁴;
 - 5.3.4 the assistance available from the Information Officer of a public body in terms of PAIA and POPIA;
 - 5.3.5 the assistance available from the Regulator in terms of PAIA and POPIA;
 - 5.3.6 all remedies in law available regarding an act or failure to act in respect of a right or duty conferred or imposed by PAIA and POPIA, including the manner of lodging

¹ Section 17(1) of PAIA- For the purposes of PAIA, each public body must, subject to legislation governing the employment of personnel of the public body concerned, designate such number of persons as deputy information officers as are necessary to render the public body as accessible as reasonably possible for requesters of its records.

² Section 56(a) of POPIA- Each public and private body must make provision, in the manner prescribed in section 17 of the Promotion of Access to Information Act, with the necessary changes, for the designation of such a number of persons, if any, as deputy information officers as is necessary to perform the duties and responsibilities as set out in section 55(1) of POPIA.

³ Section 11(1) of PAIA- A requester must be given access to a record of a public body if that requester complies with all the procedural requirements in PAIA relating to a request for access to that record; and access to that record is not refused in terms of any ground for refusal contemplated in Chapter 4 of this Part.

- 5.3.7 the provisions of sections 14⁵ and 15⁶ requiring a public body and private body, respectively, to compile a manual, and how to obtain access to a manual;
- 5.3.8 the provisions of sections 15⁷ and 52⁸ providing for the voluntary disclosure of categories of records by a public body and private body, respectively;
- 5.3.9 the notices issued in terms of sections 22⁹ and 54¹⁰ regarding fees to be paid in relation to requests for access; and
- 5.3.10 the regulations made in terms of section 92¹¹.
- 5.4 Members of the public can inspect or make copies of the Guide from the offices of Apollo Tyres Africa (Pty) Ltd and the Regulator during normal working hours. The Guide is available in English and Afrikaans.

⁵ Section 14(1) of PAIA- The information officer of a public body must, in at least three official languages, make available a manual containing information listed in paragraph 4 above.

- 6.2.13 Value Added Tax Act 89 of 1991

6.4 Apollo Tyres Africa (Pty) Ltd is bound by legislation to keep records for a period of 5 (five) years after the conclusion of any transaction. We will ensure that records are stored in accordance with our standard procedures for retaining information and records.

7. PROCESSING OF PERSONAL INFORMATION

7.1 POPIA

Chapter 3 of the POPIA provides for the minimum conditions for lawful processing of personal information. These conditions may not be derogated from unless specific exclusions apply as outlined in POPIA.

Apollo Tyres Africa (Pty) Ltd processes personal information in accordance with POPIA. In terms of our Privacy Policy, Apollo Tyres Africa (Pty) Ltd will ensure that all processing conditions of POPIA are complied with at the time of processing of personal information.

- 7.2 Purpose for processing personal information by Apollo Tyres Africa (Pty) Ltd
 - 7.2.1 Apollo Tyres Africa (Pty) Ltd will process your information in the ordinary course of the business of providing services.
 - 7.2.2 Apollo Tyres Africa (Pty) Ltd processes personal information for a number of reasons, including:-
 - 7.2.1 providing services requested;
 - 7.2.2 creating and managing supplier relationships;
 - 7.2.3 managing contracts;
 - 7.2.4 sending quotation estimates and invoices;
 - 7.2.5 general human resource and finance functions including those obligations imposed by legislation;
 - 7.2.6 to allow for proper functioning of the website which includes, amongst others, proper display of content, interface personalization and ensuring that the website is safe and secure to protect against misuse.
- 7.3 Categories of data subjects and types of personal information processed

Apollo Tyres Africa (Pty) Ltd processes personal information relating to our employees, clients, service providers, and visitors to our premises who may comprise potential clients, and interviewees/potential job candidates.

The types of personal information processed by Apollo Tyres Africa (Pty) Ltd are contained in our privacy policy and relate to both natural and juristic persons.

7.4 Disclosure of personal information to third parties

Apollo Tyres Africa (Pty) Ltd may disclose your personal information to third parties such as our associates and service providers, for legitimate business purposes, in accordance with applicable law and subject to the applicable professional and regulatory requirements regarding confidentiality.

Should Apollo Tyres Africa (Pty) Ltd disclose your information to third parties, the latter will be obliged to use that personal information for the reasons and purposes the information was disclosed for. To this end, we have agreements in place with the relevant third parties to ensure that an adequate level of security and confidentiality is adopted by the third parties to which your personal information is being transferred to.

Apollo Tyres Africa (Pty) Ltd may be obliged to disclose your personal information where we have a duty to disclose in terms of law or where we believe it is necessary to protect our rights. This includes where we are required to disclose your personal information as a result of litigation being instituted by or against us.

7.5 Transfer border / Cross border flows of personal information

Apollo Tyres Africa (Pty) Ltd may transfer your personal information to recipients outside of the Republic of South Africa. We will ensure compliance with POPIA in relation to any cross-border transfers of personal information. For example, we will ensure that the third party who is the recipient of the information is subject to a law or binding agreement which provides for an adequate level of protection similar to POPIA.

7.6 Data security

- 7.6.1 Apollo Tyres Africa (Pty) Ltd takes reasonable, appropriate and adequate technical and organizational measures to ensure that your personal information is kept secure and is protected against unauthorized or unlawful processing, accidental loss, destruction, damage, alteration, disclosure or unauthorized access. We contractually mandate any third parties to which your personal information is transferred to do the same.
- 7.6.2 Apollo Tyres Africa (Pty) Ltd regularly reviews our security controls and related processes to ensure that your personal information is secure. However, where there are reasonable grounds to believe that your personal information has been accessed or acquired by any unauthorized person, we will notify the Regulator and you, unless the Regulator or a public body responsible for detection, prevention or investigation of offences, informs us that notifying you will impede a criminal investigation.

8. HOW TO REQUEST ACCESS TO A RECORD

- 8.1 To request a record in terms of PAIA, the requestor must complete the prescribed form attached to this manual as **Annexure A**. This request must be sent to the Information Officer at the addresses provided in paragraph 3.1.
- 8.2 For POPIA-related requests to object to the processing of personal information, correct or delete personal information, the request must be made in writing on the applicable prescribed Form 1 (objection) or Form 2 (correction or deletion), which are attached to this Manual as **Annexure B**.

- 8.3 The requestor must provide sufficient detail to enable the Information Officer to identify the record(s) requested and the requestor. The requestor must indicate which form of access is required, identify the right that he/she is seeking to exercise or protect and provide an explanation of why the requested record is required for the exercise or protection of that right.
- 8.4 If the request is made on behalf of another person, the requestor must submit proof of the capacity in which the requestor is making the request, to the reasonable satisfaction of the Information Officer
- 8.5 PAIA makes provision for certain grounds upon which a request for access to information must be refused. On this basis, the Information Officer will decide whether or not to grant a request for access to information.

9. PAYMENT OF FEES

- 9.1 PAIA provides for 2 (two) types of fees:-
 - 9.1.1 a request fee, which will be a standard non-refundable administration fee, payable prior to the request being considered; and
 - 9.1.2 an access fee, payable when access is granted which must be calculated by taking into account reproduction costs, search and preparation time and cost, as well as postal costs.
- 9.2 Subsequent to a request being made, the Information Officer, shall by notice require the requestor, excluding personal requestor, to pay the prescribed request fee (if any), before further processing of the request.
- 9.3 If the search for and preparation for disclosure of the record has been made, including arrangement to make it available in the requested form, requires more than the hours prescribed in the regulations for this purpose, Apollo Tyres Africa (Pty) Ltd will request the requestor to pay as a deposit the prescribed portion of the access fee which would be payable if the request is granted.
- 9.4 Apollo Tyres Africa (Pty) Ltd may withhold a record until the requestor has paid the fees as indicated in **Annexure C**.
- 9.5 A requestor whose request has been granted must pay the applicable access fee for reproduction, search, preparation and for any time reasonably required in excess of the prescribed hours to search for and prepare the record for disclosure including making arrangements to make it available in the request form.
- 9.6 In terms of POPIA, a data subject has the right to request Apollo Tyres Africa (Pty) Ltd to confirm, free of charge, whether or it holds personal information about the data subject and request from Apollo Tyres Africa (Pty) Ltd the record or a description of the personal information held, including information about the identity of all third parties, or categories of third parties, who have, or have had, access to the information.
- 9.7 POPIA further provides that where the data subject is required to pay a fee for services provided to them, Apollo Tyres Africa (Pty) Ltd must provide the data subject with a written estimate of the payable amount before providing the service and may require that the requestor pay a deposit for all or part of the fee.

10. TIME PERIODS APPLICABLE

- 10.1 Apollo Tyres Africa (Pty) Ltd will inform the requestor within 30 days after receipt of the request of its decision whether or not to grant the request.
- 10.2 The 30-day period may be extended by a further period of not more than 30 days if the request is for a large number of records or requires a search through a large number of records and compliance with the original period would unreasonably interfere with the activities of Apollo Tyres Africa (Pty) Ltd or the records are not located at Apollo Tyres Africa (Pty) Ltd' offices

11. OUTCOME OF REQUEST (APPROVAL / REFUSAL)

Should the request be refused, the notice will state adequate reasons for the refusal, including the provisions of the PAIA relied upon; and that the requestor may lodge an application with a Court against the refusal of the request.

12. GROUNDS FOR REFUSAL TO ACCESS OF RECORDS

- 12.1 In terms of Section 62 to 69 of PAIA access granted to a record may be refused on one or more of the following grounds:—
 - 12.1.1 protection of privacy to a third party who is a natural person;
 - 12.1.2 protection of the commercial information of a third party;
 - 12.1.3 protection of certain confidential information of a third person;
 - 12.1.4 protection of the safety of individuals and the protection of property;
 - 12.1.5 protection of records privileged from production and legal proceedings;
 - 12.1.6 the commercial information and activities of Apollo Tyres Africa (Pty) Ltd;
 - 12.1.7 the protection of research information of a third party; and
 - 12.1.8 any other ground legally available on which to refuse access to the information requested.
- 12.2 Despite any provisions of PAIA, a request must be granted if the disclosure of the record would reveal evidence of substantial contravention of, or failure to comply with, the law or is imminent and a serious public safety or environment risk, and the public interest in the disclosure of the record clearly outweighs the harm contemplated in terms of section 70 of PAIA.

13. REMEDIES FOR REFUSAL

Should the requestor be dissatisfied with the Information Officer's decision to refuse access, that person may within 30 days after notification of the refusal apply to a Court for the appropriate relief.

14. AVAILABILITY OF THIS PAIA MANUAL

This manual is available in electronic and hard copies in English. The hard copies are available at the head office of Apollo Tyres Africa (Pty) Ltd as contained in paragraph 3.3. The electronic version of this manual is available on Apollo Tyres Africa (Pty) Ltd's website.

15. UPDATING OF THIS PAIA MANUAL

This manual will be reviewed and updated, if necessary_annually or on a periodic basis.
